ARTICLE III. BOARD OF DIRECTORS

Section 2. Number, Tenure and Qualifications.

The number of directors shall be no less than six (6) and no more than eleven (11). Each director shall hold office for three (3) years and until his/her successor shall have been elected and qualified. A director may serve only two (2) successive terms, with the exception of a term served filling an unscheduled absence. A former director may serve as a director if such former director has not been a director for one (1) year.

**OBRA Administrative Rules** 

Admin Rules IV.A.

Appointment

Six (6) members of the Board of Directors of the Corporation shall be elected by a majority vote of the Club Representatives at the annual meeting of the Corporation. Up to five (5) members of the Board of Directors ("At-large Directors") of the Corporation shall be appointed by a majority vote of the directors then in office. Each OBRA Club shall appoint a single Club Representative to vote in the election of directors, as these terms are defined and in a manner consistent with the applicable OBRA administrative rules. Each director shall hold office for three (3) years and until their successor shall have been elected and qualified. A director may serve only two (2) successive terms, with the exception of a term served filling an unscheduled absence.
